Do I have to answer every question?

No – taking part is voluntary and you don't have to answer every question if you don't want to. Please fill in as much as possible though because your responses are important to us.

Can someone help me with the questionnaire?

Yes – a relative, friend or carer may help you to fill in the questionnaire, but please remember that the answers should all be from your point of view.

What if I can't remember what I said on my other questionnaire?

That is okay. We are interested in knowing how you are now and the health care you have received since leaving hospital.

How did you get my name and address?

When you were in hospital you completed the first part of this survey. You were also given information about the Scottish Trauma Audit Group who collect information about patients who have had an injury. This information is held by NHS Scotland on a database as explained in the Patient Information Leaflet you were given (<http://www.stag.scot.nhs.uk/>). Your name and address have been passed to Quality Health Ltd., only so that they can send you this letter and questionnaire. They are required to destroy this information once the survey mailout has been completed. They do not have access to any other information about you.

Why is this survey needed?

The survey responses will help us to better understand how injuries like the one you had impact on people's lives. They will also help us to improve services in particular in relation to the new trauma networks across Scotland.

The survey responses will be analysed by information analysts based at Public Health Scotland. They will provide local and national reports to hospitals, Health Boards and the Scottish Trauma Network. The Scottish Trauma Audit Group will also include results of this survey in their annual National Report which can be found at www.stag.scot.nhs.uk. In all of the results reported publicly no individuals will be identifiable.

Who can access my survey responses and how will they be used?

Access to your individual responses is very tightly controlled and is restricted to authorised individuals within Public Health Scotland, the Health Board(s) where you received treatment following your injury and Quality Health Ltd. Your responses will be stored securely and confidentially.

The survey dataset – containing individual responses linked to the Scottish Trauma Audit Group data will be accessed and analysed by information analysts employed by Public Health Scotland. Individual clinicians and others involved in your care will also be able to view your responses. They will have the ability to review your responses to this questionnaire and link these with the data collected about your care through the Scottish Trauma Audit Group using the unique identification number on the questionnaire.

This will allow them to assess if any aspect of the care you were given following your injury may have impacted on the outcomes that you have noted in your responses in the questionnaire. This means that clinicians and others within Health Boards will be able to use this information to improve the care of patients who have suffered injury in the future and therefore improve the quality of life for those patients.

Only those directly involved in your care within the Health Boards will be able to access identifiable information and be able to link your responses to this questionnaire with those in the Scottish Trauma Audit Group.

An anonymised version of the survey dataset could in the future be shared with a third party for additional analysis or to be linked to other data sources. This will only be done with the approval of the Scottish Trauma Audit Group and the relevant NHS research, ethics and governance groups.
